Chair's Report



The previous year's AGM was able to be held in person in between lockdowns, and we were pleased this year to have been able to meet in the same circumstances, and with more certainty about our future plans as things rapidly return to something more akin to normal around us.

Despite the disruptions of the previous year, the Board of Directors has continued its work, meeting on several occasions, including for a very fruitful in person intentional planning day at the start of the year. Significant improvements have been made to our internal governance, with the establishment of a Finance Audit & Risk Management committee in addition to the Investment committee, a Governance and a Fundraising committee.

The Board of Directors continue to work well together in service of the Foundation, and continue to work closely with the CEO and staff team in matters of strategy and direction, and in support of their considerable efforts in progressing our work and vision.

At the Annual Meeting in 2021 we welcomed The Revd. Colleen Arnold-Moore and Chris Arnold AM to the board. They joined existing directors Carolyn Clark OAM, Geoffrey Court, Campbell Johnston, The Reverend Elizabeth Murray, Andrew Porter, Malcolm Tadgell and Richard (Rick) Tudor, the latter of whom left the board after many years of outstanding and dedicated service to the Foundation in October 2021.

All good boards and chairs have a succession plan. I intimated to the AGM last year that this would be my last year as chair, after six years in the role. I am very pleased that my fellow directors have expressed support for my nomination of Carolyn Clark OAM to succeed me as Chair and for Chris Arnold AM to be Deputy Chair.

On a personal note, looking back on the Foundation as it was when I came into the role, much has changed. At that time the Foundation had a single employee, was largely operating in isolation to the Diocese and its vision, and primarily managing and processing tax deductible donations on behalf of stakeholders and programmes in parishes. Today's Foundation is led by an energetic and passionate CEO whom the board recruited and appointed to lift our vision and achieve more, has a dedicated administrator and fundraiser / grant writer, and is involved in the corporate leadership of the Diocese in a variety of ways and is now a strong contributor to its mission.

I leave with a sense of satisfaction about where we are now, and with confidence in the future and in those who will lead us into it.

CEO's Report



Dear Friends,

As we reflect on another unique year we, at **The Melbourne Anglican Foundation**, wish to thank you for being part of a special group of people who are committed to serving God's justice and in so doing, making the word of God fully known in our communities across Melbourne.

While 2021, continued to have myriad challenges, we were thrilled to announce at the 2021 AGM held in May 2022, that the Foundation distributed over \$1.1 million in grants and donated funds to Parish Projects and special projects for the calendar year 2021. Donations to the Foundation increased overall by 17% over 2021 and the audited accounts were presented at the AGM.

One of the highlighted programmes for 2021 was the support we received from our wonderful donors as well as the Victorian State Government's Multicultural COVID Taskforce and various Philanthropic partners, for the assistance to the Farsi speaking Community in Melbourne for COVID relief. Led by the extraordinary **Revds. Hoda Ameri** and **Kaveh Hassanzadeh** and with the help of **Revd Mark Durie** and **Nicola Templeton** from **MAF**, the Iranian parish of The Emmanuel Iranian Church, Dandenong, demonstrated the clear, living message of the Gospel of Matthew 25:35. Kaveh and Hoda's dedicated leadership and tireless commitment to helping their community at this terribly stressful time, resulted in the assistance of over 10,000 people – across Melbourne, across faiths, across language.

We also launched the Charles and Frances Perry Legacy Society, honouring the first Bishop of Melbourne and his extraordinary wife who was the catalyst for the raising of funds for Melbourne's first Women's and Children's hospital. This society is to encourage **Gifts in Wills** to the Foundation for those who care about the ongoing life of the Anglican Church.

In other news, the Board of the Melbourne Anglican Foundation welcomed **Mrs. Carolyn Clark OAM** as Chair of the Board and **Mr. Chris Arnold AM** as Deputy Chair. The Board was also joined by **Mr. Gregory Reinhardt AM** and we are also very lucky to have the assistance of **Mr. Jon Rolfe** who has joined our Finance Audit and Risk Management Committee.

In addition to these sub-committees, we have created a Governance and a Fundraising Committee which have both become operational this year, 2022.

Focus Project 2021 – Culturally and Linguistically Diverse Communities COVID-19 Relief

St Matthew's Anglican Church Prahran, Hope Prahran

This project aimed to assist families in the Farsi-speaking Community in Victoria who have been affected by the pandemic, and especially those who are not eligible for any COVID-19 related financial support due to their visa status, and therefore, were struggling to put food on their table. We also aimed to address mental health issues during the pandemic for the people in the community who are unable to afford mental health support. Additionally, the need for education of communication and computer skills in the Iranian Community had become especially necessary after the pandemic, which this project aimed to address. There was also lack of knowledge and translated material regarding the COVID-19 vaccine programme which we aimed to address.

Thanks to Revd Hoda Ameri and Revd Kaveh Hassanzadeh Priests in Charge at the Iranian Anglican congregation of the Emmanuel Iranian Church for their leadership with this project.

Project Achievements

- Translated and disseminated a total of 1,137 COVID-19 and vaccine communication materials – reaching an estimate of 10,230 people in the Iranian and Afghan Farsi-speaking community.
- Delivered six sessions of computer classes to students.
- Conducted two online interviews for Farsi language Facebook pages, reaching approximately 820 individuals.
- Delivered 351 emergency food kits to 351 families and helped 1,159 individuals.
- Provided 74 psychologist appointments for those needing mental health support
- Purchased and distributed 1550 masks, and 36 hand sanitisers.
- Many asylum seekers do not hold a valid Medicare card.
- Provided support regarding medical bills, as well as psychological and pastoral support.
- Learnt of many additional needs, problems and the depth of pain and suffering across the Farsi community as they settle in Australia.





Melbourne Anglican Migrants and Refugees Settlement Fund (MRSF)

The objects of the fund are:

The pandemic is far from over, or at least the effects of it on young people are far from over. 2021 was a very hard year on young people and their leaders across the diocese. Many groups have switched from high energy activities that require large volunteer base to much smaller activities that are more flexible.

Partly this is a good development as this form of activity allows more relational focus on the young people, which given the mental health impacts of covid is very important.

However, many volunteer leaders hesitate to return to face to face youthwork and we have a large shortage of people who are the backbone of what we do. Youthwork is relational and requires there to be a high enough ratio of leaders to young people to enable relationships to be built.

As in 2020 much of the time was spent helping leaders with their own mental health, pastoral issues and building resilience in the face of a feeling of helplessness. Toward the end of the year there was an increase in hope for 2022 with a particular focus for the third and fourth term to return to normal.

Early signs this year point to tiredness still being a huge factor as many leaders haven't taken a decent break but the hope has returned as people get to work with young people which reminds them why they started in the first place.

The book of Romans suggests to me that the future is bright, this generation of leaders have suffered, we know that suffering produces perseverance; perseverance, character; and character, hope.

The programmes run through the diocese have for some leaders been what has gotten them through this time, and they would not be possible without the support of MAF.

Melbourne Anglican Chaplaincy Fund (Chaplaincy)

The purpose of the Chaplaincy Fund is to provide money:

- to any public hospital or hospital which is carried on by a society or association otherwise than for the purpose of profit or gain to the individual members of that society or association within the Diocese of Melbourne;
- to any public benevolent institution which employs or shares in the employment
 of a chaplain licensed by the Archbishop of Melbourne or has committed itself to
 employ or to share in the employment of a chaplain licensed by the Archbishop of
 Melbourne.

Hospital chaplaincy

Our Anglican chaplains provide emotional and spiritual care to patients in public hospitals, their families and hospital staff. The COVID 19 pandemic has highlighted and reinforced the role of hospital chaplains as essential health workers.

MAF grants have contributed significantly to the Anglican Diocese of Melbourne's hospital chaplaincy programme, which funds chaplains in the Alfred, Austin, Geelong, Monash, Northern, Royal Melbourne, Royal Children's and Western hospitals.

Hospital chaplains give time and a listening ear during times of great stress and suffering, assisting people to make sense of their experiences with whatever resources and beliefs the individual brings. Tradition specific support or ritual is only provided when invited, often requiring referral to someone from the individual's own faith tradition.

The pandemic has highlighted and reinforced the role of hospital chaplains as essential health workers. Levels of stress in hospitals increased dramatically, especially in acute settings like intensive care units (ICUs), and chaplains played a key role in

debriefing hospital staff and caring for patients and families, particularly given strict visiting restrictions.

Chaplains played an important role in educating patients and families about the rationale for social distancing restrictions, and health care workers about the importance of self-care.

Social distancing requirements meant that only two family members were able to visit patients at a time and this was extremely challenging for families, particularly at end of life for their loved ones. Chaplains were involved in being with other family members by video link as their loved ones have died or been given difficult news.

The State Government's decision to remove its funding for faith-based chaplaincy in hospitals was given a temporary reprieve during the pandemic and we continue our advocacy for its continuation, while making plans for its likely removal.

Work continues with the Department of Health (Safer Care Victoria), the Spiritual Health Association and Spiritual Care Australia on how best to meet the spiritual needs of patients, including advocating for the place of faith-based chaplaincy.

Prison chaplaincy

Our prison chaplains have been some of the last service providers to be prevented from working in prisons during the pandemic, a testament to their essential service to those incarcerated, and have been delivering ministry remotely when not able to attend in person. The Anglican Criminal Justice Ministry (ACJM) provides Anglican chaplains in all prisons and youth justice centres in Victoria.

Preventing Violence Against Women (PVAW)

Through a three-year funding commitment (2018-2021), the Melbourne Anglican Foundation was privileged to be one of several partners with the Anglican Diocese of Melbourne Preventing Violence Against Women (PVAW) programme.

Highlights below illustrate an astonishingly successful programme to date. Under the leadership of Programme Manager Robyn Andreo-Boosey, the PVAW team achieved, through collaboration with the Anglican Church, government, and the prevention sector:

- training over 200 people from over 80 parishes, including online during the pandemic
- staff training and student teaching sessions at Ridley and Trinity Colleges
- coaching sessions and peer learning opportunities for lay and ordained church leaders
- a grant of \$120,000 from the Victorian Government and delivering one of five 18-month faith community prevention projects in partnership with The University of Melbourne and the Multicultural Centre for Women's Health. The Whole Church Pilot project worked intensively with five parish communities, developing resources and approaches which will be extended to other parishes
- a grant of \$190,000 from the Department of Families, Fairness and Housing to equip culturally and linguistically diverse Anglican communities to prevent violence against women
- work with the Melbourne Anglican Foundation, which brokered a grant of \$95,000 from the Collier Charitable Fund to implement the Programme's 2021-2025 Strategic Plan

Staff Changes

There have been staff changes in the PVAW team over the past 12 months.

- Kerryn Lewis commenced in November 2021 as the new PVAW Programme Manager replacing Robyn Boosey who moved back to the United Kingdom to be with family.
- Sonia Couchman commenced as the CALD Project
 Officer. Sonia's work will focus on the Safe and Thriving
 CALD Anglicans communities project. A 3-year State
 Government funded project by DFFH, that will add value
 to the PVAW Programme by focusing on centering the
 needs of CALD Anglicans in this work.

- Melbourne Uni were engaged to develop a new Programme Logic and Monitoring and Evaluation Plan (Programme Logic attached)
- This has resulted in a sophisticated planning and evaluation process for the 2021-2024 phase of the PVAW programme.



Engaging Melbourne Uni adds to the credibility of our work and assists us to gather evidence about what works in preventing violence against women in Church/Faith-based communities. We see it as a priority to share our findings to the broader PVAW sector and contribute to the evidence base around this work. As a result of our contribution to the sector the ADOM is seen as a leader in PVAW in faith-based communities.

Some presentations to share our work this year include:

- Safe and Equal's Fast Track programme (a course for advanced PVAW practitioners),
- Group of religious schools involved in Respectful Relationships in Schools programme
- Different Diocese around Australia and one from Ireland.

PVAW Response and Prevention Training

The existing PVAW Response and Prevention 1-day training programme has been reviewed by the Multicultural Centre for Women's Health (MCWH). This review occurred as part of the CALD project however the learnings from this have been fed back into the broader PVAW programme. The training review has resulted in a strengthened intersectional approach for the PVAW training.

- The newly updated training was delivered on 4 June to a group of 14 Clergy and parishioners. We have broadened our reach for the training beyond Clergy to anyone interested in contributing to PVAW work in their parish. It was a full day and attendees were very engaged. People left feeling energized with ideas for ways to progress PVAW work in their parish.
- A PVAW information/training session has been planned for the Cathedral for Saturday 10 Sep. We are aiming to have approximately 30 people in attendance.

Policies and Procedures

Family Violence policies and procedures for churches have been signed off by the PVAW Committee of Management ready to be launched to churches in September.

Whole of Church Approach

We will be putting out an Expression of Interest in the next month, requesting 10 new churches to go on an 18-month journey. This will be to do a deeper dive into PVAW in their parish by undertaking the whole of church approach. This is similar to the 5 previous pilot churches process.

Communities of Practice

To support the 10 churches undertaking the whole of church approach as well as the previous 5 pilot churches an advanced community of practice will be set up before the end of the year to bring these churches together to share their learnings and gain support from each other.

A second community of practice will be set up also before the end of the year to support any other church that would like to start getting more involved in PVAW work however aren't quite ready or don't have the capacity to undertake the whole of church approach at this stage.

Individual coaching will also be offered to all of these churches.

Melbourne and Geelong's Population Growth

The combined population of Melbourne and the nearby satellite-city of Geelong is expected to grow from 5 million to 10 million by 2050 through urban infill and greenfield expansion. In response to this expected population boom 17 new suburbs are planned and are presently being built in outer Melbourne, resulting in huge population growth principally in the western and northern suburbs and some in the southeast of the city. Trends predict these areas to become home to a further 5 million people in the next 30 years.

The Anglican Diocese of Melbourne is preparing to be ready for people who want to make their homes in these new suburbs. **We want to be a living witness to Christ in these new communities.** However, we need to find new ways to reach people, who no longer trust the Anglican brand, tarnished by evidence found at the 2017 Royal Commission into Institutional Responses to Child Abuse. We strongly believe that one powerful and biblical model provided by Christ is to find ways to serve people, through acts of love and service with the community, to reach people where they are at.

Church Planting

In 2020, the Melbourne Anglican Foundation was pleased to receive a three-year commitment of AU \$250,000 from The Benefact Trust for New Ministry Presence/Church Planting in Melbourne.

Financials

The year to 31st December 2021 proved to be a very positive year for MAF in financial markets, with the portfolio up around 18.0%. Income dramatically recovered from the prior year's Covid lows. Despite the ongoing interruptions from the pandemic the Australian equities market rose steadily throughout the year to close +17.2% higher. International equities markets rose +26.0%. Although inflation was starting to rise it was seen as transient, due in the most part to bottlenecking and supply interruptions from the ongoing Covid lockdowns. In March, when the official cash rate was 0.1% pa, Philip Lowe, the head of the Reserve Bank, now infamously, said that interest rates would not rise until at least 2024. The complacency toward the inflation threat and the low interest rates continued to fuel the property and investment markets.

In 2022 there was a major shift in markets with the realisation that we are now facing a rising inflation and interest rate environment, without the Central banks sitting behind equity markets with supportive quantitative easing strategies. Over the top of this uncertainty, we also have the horrendous Ukraine/Russian situation, without any real idea of the time frame around when or how it will be resolved. This situation is fuelling inflation expectations with rising oil prices feeding into petrol prices and shortages expected in the grain markets.

Markets are having to come to grips with how to factor rising interest rates into valuations. We have seen growth stocks sell off in favour of cyclical and value stocks. Investors are rotating out of the sectors that could be hurt by increasing rates - selling utilities, real estate investment trusts, housing, growth and tech stocks and rotating back toward commodities, energy and resource companies. Concern that continuing aggressive rate increases by the central banks would push the economies into recession has now also caused banks and resource stocks to sell off, having been relatively immune to broader market weakness early in the year.

Whilst not immune to this pull back the Foundation's portfolio is weathering the storm. We are long term investors who invest through the cycle. We concentrate on investing in quality companies that have good management, pricing power in their markets and provide good sustainable income to the Foundation, which is proving its worth at the moment.




